Subject: Confiscation data

This request asked for:

Information relating to convicted offenders for whom the SFO (or any predecessor bodies whose duties it might have taken over) is, or has been, responsible. Including:

- A full list of all offenders given a confiscation order of £1 million or more.
- The full name of each of these offenders.
- For each offender, the court at which they were convicted, the date of conviction and the sentence imposed.
- For each offender, the court at which the confiscation order was imposed and the date when it was imposed.
- For each offender, the amount of the confiscation order and the deadline for payment imposed by the court and the default term set by the court.
- For each offender, the amount paid so far.
- For each offender, the current outstanding amount, including interest.
- For each offender, whether they have now served the substantive sentence imposed for the crime or crimes over which the confiscation order was imposed.
- For each offender, who has failed to pay, please state whether the default sentence has been activated.
- For each offender for whom a default sentence has been activated, please state whether the relevant time has since been served.



The information requested is contained in the data table below.

The information should be read with the following caveats in mind:

- the SFO does not hold complete data for orders made prior to 2004;
- information as to whether persons are still serving their sentence is provided so far as is known and there may have been changes in circumstances of which the SFO is unaware; and
- much of the data is sourced from the Joint Assets Recovery Database ("JARD")
 which is a centralised database holding data input by the Court Service and
 others across the prosecution and law enforcement bodies within the UK. The
 SFO is not in a position to verify the accuracy of the data extracted from JARD.

The default sentence has not been activated in a number of cases. Reasons include:

- the deadline for time to pay has not yet expired;
- the magistrates court is content with the defendant's co-operation at present;
- there are ongoing appeal proceedings;
- the defendant has been deported prior to activation of the default sentence;
- the defendant is seeking a certificate of inadequacy;
- the SFO has not sought a listing as other enforcement options are being pursued; and
- the order was satisfied in full with the assistance of overseas authorities but interest accrued during that process.
